Dear Applicant

Thank you for your enquiry regarding Foreign Birth Registration (FBR) **on behalf of a minor.**

Attached please find an FBR application form, together with some guidelines and a check list of certificates and documents necessary to support your application (see overleaf).

All certificates, i.e. birth, marriage and death, must be issued by the appropriate registering authority, must be long form / full version and must be original. We do not accept photocopies or copies certified by your witness.

Supporting documents must also be original, however, a certified copy of your driving licence will be accepted. If you require your documents to be returned prior to the completion of your application, please enclose a registered mail or courier envelope so that we can return them immediately.

The application takes approximately four (4) months to complete, but in some cases it may take longer.

A passport application form will be sent to you with your certificate of citizenship upon completion of the process.

FOREIGN BIRTH REGISTRATION FOR APPLICANTS UNDER 18 YEARS OF AGE

Anyone born outside Ireland who, at the time of their birth had a parent, who was an Irish Citizen, **otherwise** than by birth in Ireland, may become an Irish Citizen by application for Foreign Birth Registration.

Others who may be eligible to claim Irish Citizenship include great grandchildren who were born after 17 July 1956. If neither of the child's parents were registered Irish Citizens at the time of the child's birth, they can claim Citizenship if one of their parents registered prior to 1 January 1987.

GUIDELINES FOR FOREIGN BIRTH APPLICATION

- Applicants must be the Irish citizen parent of the minor and are asked to pay particular attention when completing the application form. An incorrectly completed form could later result in the application being declared invalid
- All changes of name of the applicant and/or his/her parent and/or grandparent should be accompanied by an explanation and full supporting documentation e.g. marriage certificate, deed poll record
- You may wish to obtain Irish birth, marriage or death certificates from the General Register Office. Application forms are available online at www.groireland.ie
If born in Northern Ireland, birth, marriage and death certificates may be obtained from the General Register Office for Northern Ireland.

- The fee for Foreign Birth Registration is \$90
If you already have an application form, please check that it shows the current fee

CHECK LIST FOR FOREIGN BIRTH APPLICATION

Minor (Section A)

- Long Form Birth Certificate
- 2 x passport photographs signed and dated by the parent and by the witness from Section E on the application form. The photos should not be more than six months old
- 1 x current ID e.g. a letter from a school, GP, health board, bank which states the full name and residential address of the minor. ID must be dated within the last six months

Parent/Applicant (Section B)

- Long Form Birth Certificate
- Long Form Civil Marriage Certificate (if not married, please state)
- 3 x current, original forms of identity one of which must include your photograph and one which must include your current residential address. The third must include either your photograph or your residential address. Acceptable forms of ID are passport, driving licence, student card, telephone bill, power bill, bank statement. We will accept a certified copy of your driving licence but all other IDs must be current and original. Residential IDs must be dated within the last six months.
- 2 x passport photographs signed and dated by the witness from Section E on the application form. The photos should not be more than six months old
- Proof of ID for the witness e.g. business card, letterhead, stamp or seal stating that person's identity and profession
- Evidence of entitlement to Irish citizenship (where applicable)

Grandparent (Section C – if applicable)

- Long Form Birth Certificate
- Long Form Civil Marriage Certificate (if not married, please state)
- 1 x current form of ID that includes photo or, if deceased, Death Certificate
